If you did not send someone to the PestSure Autumn Safety and Loss Prevention Meeting in September, you missed a fantastic opportunity. The good news is you have access to much of the meeting content on the PestSure Website.

This year's agenda included five different company case study presentations. The actual work product from these companies was shared during the meeting and attendees spent time finding out the best way to address complicated situations by hearing about the trial and error process and finally the best practices that resulted in these case studies.

Mike Voss from Cook's Pest Control shared his detailed process for developing a respirator program for Cook's. Richard Spencer of Arrow Exterminators shared many of the challenges they encounter with ladder use and some fantastic solutions for safe climbing and working. Eric Paysen of Lloyd Pest Control lead us through the involved process of protecting workers from falls when they are doing work such as tenting or tarping an entire structure for fumigation.

PestSure in conjunction with Karen Behgly at Plunkett's Pest Control developed a Functional Job Screen for new hires. The development and testing took place at Plunkett's and resulted in a Job Screening tool that can be utilized at the Physical Therapy Center of your choice. The intent is to hire employees who are physically capable of performing the tasks of our job without risking injury. Plunkett's has already seen a change in the suitability of job and job candidate.


